Where to find us?

When you come from Belgium:

- take the Highway E411 direction Luxemburg
- go out to Strassen - direction Luxemburg-centre
- go on Arlon's road up to the Place de l'Etoile
- turn to the right to the Boulevard Grand duchess Charlotte
- at Winston Churchill Square turn twice to the left in the boulevard Joseph II
- go straight ahead up to Robert Schuman Square (don't go into the tunnel)
- at the traffic lights, turn to the left in rue du Glacis and keep to the right
- take the second street to the left to arrive in the avenue du Bois

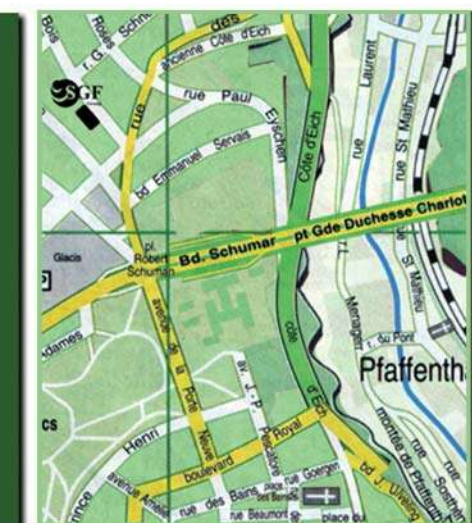


When you come from Germany:

- take the highway Trier-Luxemburg
- please, take the Luxemburg-centre exit
- drive on up to the Bridge Grand duchess Charlotte (don't go into the tunnel)
- after the bridge, turn to the right and keep to the right (you're in rue du Glacis)
- take the second street to the left to arrive in the avenue du Bois

When you come from France:

- take the highway Metz-Luxemburg
- take the Luxemburg-city exit
- go on to the by-pass direction Luxemburg-centre up to the Viaduct
- cross the bridge
- take the tunnel which ends in the Boulevard Royal
- turn to the right as soon as possible, then you will be in the avenue de la Porte Neuve
- go on straight ahead up to Robert Schuman Square
- at the traffic lights, drive on straight ahead in rue du Glacis and keep to the right
- take the second street to the left to arrive in the avenue du Bois
